NOTES FOR THE GUIDANCE OF AUTHORS

It is hoped that some of the following notes may prove helpful to authors who have kindly consented to write articles for the *Journal*. The editor is always willing to offer further advice, if required, during the preparation of an article.

Time Factor.—The *Journal* is issued in January, April, July and October and each issue takes approximately three months to produce. Articles must therefore be received by the editor at least four months before the month of issue in order to allow time for correspondence should this prove necessary. Even if received in good time, it may be necessary to hold certain articles over for a subsequent issue in order to create a satisfactory balance of subjects in any one issue.

Copyright.—The copyright of any article is shared by the *Journal* and the author. It is therefore preferable that articles by Naval Officers should be submitted to the *Journal* before being offered to the technical Press and Institutions. It is essential to inform the editor if an article has already been printed or submitted for printing elsewhere, or if an illustration is the copyright of a firm, when the proper steps can be taken in order to avoid infringement.

Security.—Material submitted must not be above 'Restricted' security classification. The editor does not wish to lose the opportunity of good articles for this reason and authors are therefore invited to consider the possibility of omitting reference to individual items of higher classification in order that the whole of their articles may be classified no higher than 'Restricted'.

Title.—A short main title for the article is most desirable as this greatly facilitates indexing, reference and quotation.

Cross-Headings.—Authors should indicate which are main and which are subsidiary cross-headings in their articles, and to remember, for example, that a central cross-heading logically governs all that follows until the next central cross-heading. Subsidiary cross-headings are an advantage if used approximately every 300 words, if this is suitable for the article.

Length of Article.—An article of 3,000 to 5,000 words with illustrations creates a nice balance, but shorter or longer articles are equally welcome. Arrangements can be made to divide longer articles into parts for succeeding issues. A full page of the *Journal* contains about 600 words.

Style.—Authors are invited to use their own style, giving due consideration to arrangement, conciseness, punctuation and the consistent spelling of words. It makes the editor's work easier if the use of abbreviations, the spare use of capital letters, the form of cross-headings, the use of hyphens, and general layout conform to the editorial standards. These may be noted in recent issues of the *Journal*. The main standard used is the *Concise Oxford Dictionary*. The standard adopted for abbreviations is British Standard 560 : 1934—*Engineering Symbols and Abbreviations* (see *Journal of Naval Engineering*, Vol. 2, No. 3, page 215).

Accuracy.—Technical accuracy is important and any suggestions which may be raised at headquarters will be referred to the author for his comment.

Script.—Articles should be typewritten in double spacing with an inch margin, and forwarded in duplicate. Mathematical formulae should, however, invariably be written very clearly and carefully in manuscript. If possibility of doubt exists, explain in the margin the symbols required.

Galley proofs will normally be sent to the author for proof reading before the book proof is made, but this would not be practicable in the case of authors far distant from the United Kingdom.

Illustrations.—These can add much to the value of an article. Photographs should be in sharply contrasting black and white, glossy, unmounted and normally not less than 6 in. \times 8 in. Facilities generally exist in commands for taking appropriate photographs for official purposes.

Graphs and line drawings should be made at least three times the size of the required final picture, with bold lines and lettering to permit reduction in block making.

Figure numbers and short captions should be printed or typed on separate pieces of paper and gummed to the back of all illustrations and diagrams. It should be indicated in the script margin where the author would like these placed. The editor will then work to this requirement as closely as possible. Please do not write on the back of prints or use paper clips. Both these practices are liable to indent the glossy surface and spoil reproduction.

Use Arabic figures when numbering illustrations and diagrams thus :—Fig. 6, Fig. 15. Use Roman figures for tables thus :—Table IV.
