Annual Report of the Council and Accounts for the year ended 30 September 1979



The past year has been one in which the Institute has endeavoured to improve its financial position whilst exploring possibilities for the provision of greater services to members and developing the Institute's learned society activities.

OFFICERS AND MEMBERS OF COUNCIL

Mr. J. McAfee succeeded Mr. D. H. Alexander as President and Mr. L. D. Trenchard was elected Deputy President. Mr. G. McNee was elected to serve as Honorary Treasurer. During the year Dr. R. A. Goodman resigned as a Fellow of Council and Mr. E. J. S. Agius was elected by Council to fill the casual vacancy.

COUNCIL

During the year the Council approved the arrangements for the redecorations and alterations to the first floor conference facilities. The changes involved included the moving of the Marine Engineers Club from the first to the second floor and the extension of the kitchen area. Two additional conference rooms are now available for letting.

Following a Council suggestion arrangements have been made for the holding of meetings of Branch Chairmen on the morning of the Council meeting days.

The last Annual Report included a reference to the formation of a Joint Working Party with the Royal Institution of Naval Architects. This Group has had several meetings, and discussions are continuing.

The Institute is awaiting the publication of The Report of the Finniston Committee of Inquiry. Preliminary discussion has taken place within the Institute and further action will be taken on publication of the Report.

Council Advisory Committee

The various specialist groups of the Council Advisory Committee have met frequently throughout the year.

a) Office Bearers Section

The Office Bearers section has considered a complete list of Institute representatives on outside bodies, Institute representatives at CEI and Corresponding Members. The lists of representatives have been reviewed and approved by Council.

b) CEI Affairs Section

Meetings of representatives have been held to co-ordinate and collect ideas which form the basis of the Institute's policy in dealing with CEI matters. When the Finniston Report is released members of this section will be asked to put forward the Institute's views at CEI meetings.

c) Planning Affairs Section

An analysis of Institute membership and statistics relating to geographical distributions have been examined. The section has been concerned to note the decline in overall membership trends and has considered various possible courses of action which might be taken to improve the situation. Branch boundaries in the United Kingdom have been examined and certain recommendations made. The section has also under review the possibility of reciprocal membership arrangements with other Institutions. Encouragement has been given to the Branches by providing financial incentives and setting out proposals and objectives.

d) Policy Affairs

Policy proposals have been examined and discussed.

e) By-Laws Section

A small group of Council Advisory Committee members have examined minor amendments to the Institute's By-laws.

Other Committees

BUILDING DEVELOPMENT GROUP

This Group considered and monitored plans for the alterations to the first and second floors, these building plans to be completed by 30 September 1979. The work involved included the provision of a new bar and club facilities for the Marine Engineers Club on the second floor, the extension and modernisation of the kitchen facilities on the first floor and the redecoration of the Alfred Robertson Room. The work was completed on time and was available for inspection by members of the Institute on President's Day, 2 October 1979.

OFFSHORE SAFETY INQUIRY GROUP

This ad hoc Group considered the proposals of the Burgoyne Committee and submitted recommendations on behalf of the Institute. The Burgoyne Committee considered the arrangements for the control of offshore installations, including drilling and production regulations, and inquired into the adequacy and effectiveness of the arrangements. In view of the importance of offshore work the committee has been formally established and will meet on a regular basis.

EEC COLLOQUIUM

Arrangements are in hand to discuss with officials of the EEC matters affecting marine engineers and on which the Colloquium of European Marine Technological Institutions would wish to be consulted.

DIVISIONS AND BRANCHES

In February 1979, the then President and the Director and Secretary visited the Institute's Australia/New Zealand Division, the Singapore Branch and the Joint Branch in Hong Kong.

In Australia the outstanding impression created was one of enthusiasm and loyalty to the Institute.

Australia/New Zealand Division

A Divisional conference was held in Auckland. The Divisional Council was seeking representation at the Maritime Training Academy in Tasmania. The Division was active and enthusiastic and it was reported that support for technical meetings and Institute literature continued at a high level. A history of the Australia/ New Zealand Division has been received. This document was compiled by Mr. J. B. Thomson the Divisional Secretary who will be retiring from this post in the near future. Mr. Thomson has rendered valuable service to the Institute over many years for which our thanks are due.

India Division

Discussions were held during the visit on the funding of the India Division. Detailed arrangements were set out and have been considered by the Council following which finance has been made available for a divisional office to be set up. The Indian branches have continued to hold meetings on a regular basis.

Branches

Throughout the year branches have been encouraged in their activities and offers have been made to help the branches in both their administrative work and financial commitments. Branch activities during the year have either been maintained at their present level or been increased. The Institute has been taking steps to form a Branch in Barcelona.

During the year there was an encouraging response from members in Greece who have actively supported the formation of a joint I.Mar.E/RINA Greek branch. The first technical lecture has been delivered and attendance was encouraging.

The Institute is considering and investigating the possibility of forming more joint branches with the Royal Institution of Naval Architects and in appropriate cases with other Institutions. Steps are being taken to promote the Institute in other countries.

Canada

Following a visit of the Deputy President to Halifax in June 1979, arrangements have been made for the Deputy President and the Director and Secretary to visit eight centres in Canada. The agenda for the meetings provides for discussion of the services which the Institute renders to its members in Canada, our relationship with the Canadian Institute of Marine Engineers, and our future course of action.

FINANCE AND ACCOUNTS

The Revenue Account shows a substantial increase in rental income following negotiations of new leases with tenants. The increase in rental income excluding service rents amounted to £242,945. The Revenue Account shows a deficit of £83,851 as regards expenditure attributable to services to Members. Income from other sources amounted to £308,662 resulting in a surplus for the year of £219,811 after making a provision of £5,000 in respect of book stocks.

The Appropriation Account incorporates the profit arising on the disposal of investments and shows appropriations totalling £372,488 including a transfer to the Capital Development Fund of £350,988 in respect of expenditure incurred on the extension of the building and interest paid during the year. The appropriations exceed the surplus of the year and reflect the utilisation of £146,290 from the accumulated reserve at 30 September, 1978. The resultant balance on the reserve fund at 30 September, 1979 is £64,357.

The refurbishing work referred to in the accounts as phase 1(a) had been substantially completed at year end and note 4 to the accounts records details of expenditure including the payment of interest of £96,679 to Morgan Grenfell representing interest charged for three-quarters of the year. In the previous year, the whole of the interest charge was rolled over with the consequent increase to the amount of the loan outstanding.

MARINE MANAGEMENT (HOLDINGS) LIMITED

The affairs of the Company are reported under the headings of each of the three Divisions. The profits of the Company are transferred to The Institute of Marine Engineers in full.

Activities Division

The Activities Division has had to steer a difficult course throughout the financial year. Priority has been given to learned society interests, but at the same time efforts have been made to maximise the return on assets to the ultimate benefit of the members.

The marine book sales market in the United Kingdom is steadily becoming more difficult, an adverse factor being the decline in the tonnage of the British Merchant fleet. The day to day work of the Activities Division brings firm indications that there is an international role for the Institute of Marine Engineers and, it is felt, this must be followed up and developed.

In each of the activities which are briefly described in this report, there is an international flavour which attracts guests from overseas countries.

CONFERENCE CENTRE

This has been a successful year during which a great deal of life and activity was brought into 76 Mark Lane on as profitable a basis as possible, with due regard for learned society events.

BOOK SALES

As stated in the opening remarks of the Activities Division report, the international market has been investigated. Many of the Institute's publications are still valid sources of information but the demand in the English speaking section of this market has been fully met. In common with certain other major United Kingdom publishers, pirate copies of our publications have been circulating for sale in the Middle and Far East. The translating and publishing of our books and Transactions into Spanish, Portuguese and Greek is under consideration. This arrangement whilst not involving the Institute in any cost, could generate income through royalties.

Management Division

SUBSCRIPTIONS

The rates of subscriptions for the 12 months from 1 October 1979 will remain unchanged.

Membership

The total number of elections is slightly up on last year 605 (598 in 1978). Elections to the Corporate class of membership has, however, declined 81 (in 1978 125), but the class of Associate Member has again seen the highest intake 245 (in 1978 213). The number of resignations is down 269 (366 in 1978). 29 members qualified for certificates of fifty years service. Council regrets the tragic loss of Admiral of the Fleet The Earl Mountbatten of Burma, K.G., P.C., who was an Honorary Fellow. The number of Honorary Fellows remains the same as Sir James Ramsey, K.C.M.G., C.B.E., D.S.C., Governor General of Queensland was elected to this class in September 1979.

It will be seen from the membership table that the overall membership figure has fallen by 1487. This is largely due to an increase in numbers removed from the Roll for non-payment of subscriptions. Members will recall that the number removed from the Roll last year was lower than in previous years as every effort was being made to retrieve the situation. Although some measure of success was achieved, with an increase in subscription income, there still remained a substantial number of members whose subscriptions were two years or more in arrears. It is hoped to reduce the number of subscription arrears even further during the next 12 months.

Members are reminded that if they allow their membership to lapse readmission to the Institute may be allowed on reapplication to the class of membership for which they are qualified in accordance with the By-laws in force at the time they reapply. One consequence of this is that members may not regain their previous class of membership with appropriate registration.

Memorial Building

Negotiations for the letting of all the tenants' area have now been completed and, with one exception, the licences have been executed. Under the new arrangements the tenants will be responsible for meeting the costs of servicing the common parts and sthe leases are for relatively short terms it should be possible for the Institute to ensure that rental income is reviewed regularly. The alterations approved by Council should ensure that the conference centre will be able to operate efficiently without any significant capital expenditure in the near future. As part of the overall arrangement for the reorganisation of the use of the premises the Marine Engineers Club have agreed to the automatic admission of each member of the Institute as a member of the Club.

Education and Training

This year has seen the appointment of an Education and Training Officer who has assumed responsibility for the Education and Training function within the Institute. It is intended that this most important function be developed to such an extent that the Institute is recognised as a leading authority on the education and training of marine engineers. This is a new venture for the Institute and members are asked to support the Education and Training Officer in his work.

He is currently making a tour of all Institute branches in the United Kingdom, and marine schools in order to discuss education and training matters. A new careers booklet entitled "Marine Engineering—A Challenging Career" has been produced together with posters to publicise the booklet. The Institute is also taking an active part in careers and schools liaison work, which includes representation at careers conventions, schools careers evenings and other similar activities.

Regulations governing the practical training for those wishing to become chartered engineers, technician engineers and engineering technicians have been submitted to CEI for approval.

By-laws

The Council has under consideration a letter received from the Privy Council which includes the comments made by CEI on the proposed changes in the Institute's By-laws. CEI are unable to support the proposed changes.

Media Division

The Division is responsible for organising the learned society activities of the Institute such as evening meetings, conferences and the library. The Division is also the Institute's publisher and publishes the M.E.R., Transactions and Text Books.

EVENING MEETINGS AND CONFERENCES

During the year 14 evening meetings and four conferences were held. Three of the conferences were arranged jointly with other organisations; "North Sea Corrosion—What Have We Learnt" in Edinburgh with the Institution of Corrosion Science and Technology; "Operational Aspects of Propulsion Shafting Systems" with the International Committee on Marine Engineering Systems. (Engineers from 12 countries are members of I.C.M.E.S. which is a forum for discussing marine engineering design and operational problems); and "The Effect on Ship Design and Operation of the 1978 I.M.C.O. Tanker Safety and Pollution Conference" with the Royal Institution of Naval Architects. The fourth conference was on "Ship Dynamic Positioniand Mooring Systems—Electrical Aspects". All the conference papers are available for sale to both members and non-members.

SYMPOSIUM ON SHIPS AND MARINE ENGINEERING AT THE SCIENCE MUSEUM

A one day symposium was held in January 1979 for careers advisers and school leavers. The attendance was encouraging bearing in mind the transport difficulties caused by bad weather combined with a train strike. The symposium was organised jointly the Science Museum and the Institute. No papers were printed.

PUBLICATIONS

Marine Engineers Review

The new editorial features initiated last year were successfully carried through with the exception of the "Superintendent's problems" page which suffered from lack of contributions. The average number of editorial pages and the proportion of contributed technical articles increased substantially over the year.

The technical and managerial content of letters to the editor (Postbag) increased satisfactorily but there was still a shortage of comments on the journal itself. However, a reader survey yielded a fair return (about 10 per cent) and showed that the great majority are satisfied with the content of the journal. Regular features on New buildings; Engines; and Public Research were added during the year and special features covered: Lubrication; Galley equipment: Deck Machinery; Electrical equipment; Pumps; Corrosion; Auxiliaries; and Instrumentation.

From January 1979 a new cover design for M.E.R. was printed which gives it a more modern appearance and permits bled-off advertisements, making for a more attractive front cover.

A new Advertisement Manager was appointed in April and at the same time advertisement sales outside the U.K. were reorganised with a view to saving commissions and increasing revenue.

Technical Books

During the year a further three parts of Marine Engineering Practice were published:—

- Part 15 Operation of Machinery in Ships: Steam Turbines, Boilers and Auxiliary Plant by A. Norris, C.Eng., F.I.Mar.E.
- Part 16 Ship's Gear: A Review of Deck Machinery by D. H. Beattie, C.Eng., F.I.Mar.E. and W. M. Sommerville.
- Part 17 Slow Speed Diesel Engines by S. H. Henshall, C.Eng., F.I.Mar.E. and G. G. Jackson.

The Institute is seeking authors for text books to be produced in the future.

Preprints and Transactions

The £2 per annum fee for the automatic despatch of transactions for papers presented at evening meetings has been cancelled and members are entitled on request to one free copy of each paper. A fee is charged for conference papers.

The printing process used for technical papers has been changed from camera ready copy to a photo-setting process which apart from giving a greatly improved appearance provides savings on paper and postage.

LIBRARY AND INFORMATION SERVICE

Over the last year, several significant changes have been made in the organisation of the Library, and in the services offered by the Information Service. The overall layout of the library has been altered in order to provide simplified sequences of books and journals. The older material has been segregated from the contemporary collection and now forms an historical section. These changes together with improvements made in the cataloguing and indexing systems, will assist members in their personal searches for information.

The addition of a second qualified librarian/information officer to the staff, has enabled the Institute to offer a greater range of information services. These are currently being offered free of charge to members, and at an economic rate to industry. Early attempts at publicising the service have met with an encouraging response from industrial users and overseas members.

Computer Terminal

In a move to improve the efficiency and scope of the service, a Texas Instruments 743 computer terminal linked to the Lockheed Dialog data bases has been installed. It will also be connected to Euronet Diane when this service becomes available.

There are two types of data base. Firstly, bibliographic data bases which contain over 20 million references to published information and provide lists of references on specific subjects. The customer selects the references he wishes to see and the library obtains the synopses or articles. The second type is the numeric and factual data bases which produce actual technical information.

STAFF

Miss L. Boothby was appointed Conference Centre Manager. Mr. B. Denyer, B.A., who joined the Institute in August 1978, took over as Technical Information Officer in October 1978. Mr. M. George was appointed Advertisement Manager of the M.E.R., in April 1979. Mr. M. Weston, B.A., was appointed Assistant Technical Information Officer in October 1978. Miss C. F. Thimann resigned as Technical Information Officer in October 1978. Mr. P. Buckton, Registrar, was appointed Education and Training Officer, in addition to his other duties, and Miss B. A. Harrison was appointed Assistant Registrar.

In addition there has been further expenditure in respect of Phases 1, 2 and 1A which has been paid or is payable by The Institute of Marine Engineers to contractors and other third parties in the amount of £358,278 (1978—£94,650) which together with £196,263 (1978—£98,903) referred to above gives a total of £554,541 (1978—£193,553 in respect of Phase 1 and 2)—see Note 4.

No amortisation has been provided on the leasehold property.

Valuation:

In the opinion of Baker Harris Saunders the capital value of the Institute's leasehold interest as at 30 September, 1979, for Balance Sheet purposes, was not less than a figure of £7,300,000 (1978—£6,000,000). This valuation, dated 1 November, 1979, assumes that the property will continue to be held by the Institute as an investment and to provide accommodation for the conducting of the day to day business of The Institute of Marine Engineers.

Minutes of Proceedings of the Annual General Meeting 1980

The Ninety-first Annual General Meeting was held at the Memorial Building, 76 Mark Lane, London EC3, on Thursday, 13th March, 1980 at 5.30 p.m.

The President, Mr J. McAfee, was in the Chair.

The President referred in his introductory remarks to the meeting which would be held immediately after the Annual General Meeting on the subject of the Finniston Inquiry into the Engineering Profession at which the Principal Speaker would be Mrs E. M. Sadler, MA, CEng, MICE, a member of the Finniston Committee of Inquiry.

Annual Report of the Council and Accounts for the year ended 30th September 1979

The Director and Secretary (Mr J. Stuart Robinson) presented the Annual Report and the Honorary Treasurer (Mr G. McNee) presented the Annual Accounts for the year ended 30th September 1979.

The adoption of the Annual Report and Accounts was moved by Mr J. McNaught and seconded by Mr G. R. Hodge.

Before putting the motion to the meeting the Chairman asked if there were any questions relating thereto.

Mr E. R. Hall proposed the following amendment which was seconded by Mr A. L. Covell:

'Provided a supplementary report be published over the same signatures as on the report under notice and within the next 60 days including the account, balance sheet and auditors' report of the CEI for the year ended 30th September 1978 which the Institute is required to publish by CEI By-Law 79 together with apologies for the delay in publication.'

The Chairman put the amendment to the meeting which amendment was lost.

The Chairman then put the original motion for the adoption of the Report and Accounts before the meeting and declared the motion carried

Re-appointment of Auditors and authorisation for Council to fix their remuneration

The following motion was put to the meeting by Commander M. B. F. Ranken, seconded by Mr J. E. Gander and carried:

That the Auditors, Messrs Finnie Ross Allfields, be re-appointed to hold office until the conclusion of the next Annual General Meeting and that the Council be authorised to fix their remuneration.

Report of the Scrutineers

The Chairman, before asking the Scrutineers to deliver their report, referred to By-law 48 which required that against the name of each candidate for election there shall be stated 'his present position, together with brief details of his career'. It had been brought to his attention that the details printed against the name of one of the candidates gave a misleading impression of his career in so far as the candidate's present position had been omitted due to an error by the Institute staff when editing the career material supplied by the candidate in order to bring it within the requirement of brevity. He stated that an explanation had been given to those persons who had raised the issue and after apologising to the meeting on behalf of the Institute, invited representations from the floor before making a decision on the matter.

After hearing comments from the floor, the Chairman decided that it would be unfair for any candidate for election to Council to have his candidature invalidated on a technicality not of his own making and in accordance with By-law 54 he declared the result of the ballot about to be announced valid.

The Chairman advised the meeting that Mr H. Knight had indicated his willingness to stand down, and he put to the meeting a proposal that Messrs T. Kameen, A. L. Covell, R. F. Thomas and G. Victory be appointed Scrutineers for the year 1980/81.

The proposal was duly accepted by the meeting.

Vote of thanks to the President

Mr L. D. Trenchard in proposing a vote of thanks to the President, Mr J. McAfee, referred to the able manner in which Mr McAfee had carried out the duties of President. He commented that Mr McAfee's year as President had not been an easy year, with the Finniston Report in the offing which had made it difficult to plan the future progress of the Institute. Mr Trenchard referred to Mr McAfee's service as the Institute's representative on CEI, paying tribute to his thoroughness in attendance and reports. Reference was also made to the building works which had been completed during Mr McAfee's term of office. Mr Trenchard informed the meeting that Mr McAfee had performed his Presidential duties at a time when Mrs McAfee had been in poor health and asked the meeting to express their thanks and appreciation for the services rendered, coupled with the wish that Mrs McAfee would be restored to good health in the near future.

In reply Mr McAfee referred to his twenty years' service on Council and to his Presidential year which he had greatly enjoyed.

He foresaw an exciting time ahead, despite a number of difficulties with which the Institute would have to cope, including the finance of the Memorial Building, the state of the British marine industry, declining membership and the proposals of the Finniston Committee.

Mr McAfee concluded by expressing his thanks to the Director and Secretary and the staff of the Institute.

Committee

The Committee have experienced a very sad year with the deaths of Mr Strachan, Mr Milton and Mr Cromarty. These gentlemen had devoted a great deal of time and effort to furthering the interests of the Guild and will be sadly missed.

Since the date of the last report there have been five committee meetings.

Applications for assistance

A steady flow of new applications for advice or assistance were received during the year. Three new grants have been awarded.

Guild House

It is with great sadness we report the deaths of Miss E. Walker, who had been a resident at Guild House since 1957, and also Mr A. J. Verman Decorations and improvements have taken place during the year, including the conversion of the central heating system from oil to gas. Three new permanent residents have entered Guild House and the number of holiday guests has increased this year.

Branch representatives

Our thanks are once more extended to Branch representatives for their help in maintaining close contact with recipients of grants, also visits made to members on behalf of the Guild and for collections made at their annual dinner dances.

Accounts

The Revenue Account for 1979 shows a surplus of £4,364 as compared with a surplus of £7,449 in 1978. Although the surplus is considered insufficient to counter the reducing value of money and the additional calls on the Guild, it should be looked at against the lower income from Members' Contributions and Donations and the Charity Ball, and the extra £2,000 provided for Guild House Maintenance Reserve. Dividends and interest fortunately show an increase of £3,698.

The market value of investments at 31st December, 1979 was £124,241, i.e., £11,093 above book value.

The Institute of Marine Engineers Guild of Benevolence

Minutes of Proceedings of the Annual General Meeting 1980

The 46th Annual General Meeting of the Guild of Benevolence was held at the Memorial Building, 76 Mark Lane, London, EC3, on Thursday, 13th March, 1980 at 3 p.m.

Mr R. Munton (Chairman of the Guild) took the chair.

Minutes of the preceding Annual General Meeting The minutes of the preceding Annual General Meeting, having been circulated, were taken as read and signed as a correct record.

Presentation of Annual Report by the Secretary

The SECRETARY (Mr J. Stuart Robinson) presented the report. He said the Committee had experienced a very sad year with the deaths of Mr Strachan, Mr Milton and Mr Cromarty, who had devoted a great deal of time and effort in furthering the interests of the Guild and would be sadly missed.

Since the date of the last report there had been five committee meetings. A steady flow of new applications for advice or assistance had been received during the year and three new grants had been awarded.

With regard to Guild House, it was with great sadness that he reported the death of Miss Walker who had been a resident of Guild House since 1957 and also of Mr A. J. Verman. Decorations and improvements had taken place during the year, including the conversion of the central heating system from oil to gas. Three new permanent residents had entered the Guild House and the number of holiday guests had increased during the past year.

Thanks were extended to branch representatives for their help in maintaining close contact with the recipients of grants and also visits made to members on behalf of the Guild and for the collections made at their annual dinner dances.

Presentation of Annual Financial Statement

The HON. TREASURER (Mr J. McNaught), in presenting the Annual Financial Statement, said that owing to a merger the Auditors now had a different name, Finnie Ross Allfields, instead of Allfields; however, they still had Mr Mostyn Jones and Mr Thompson had done the accounts at the Guild.

As would be seen from the Guild's Revenue Account, the surplus for the year was slightly down on the previous year, which was partly due to a low surplus from the charity ball, low income from members and additional money needed to maintain the Guild House. Dividends and interests fortunately still showed an increase. The Guild House support from the funds was a little more than the previous year, but taking inflation into account had been well maintained. Relief distributed had increased, approximately 10 per cent, which was good and he would like to see that increased again if funds were available.

The Balance Sheet reflected the changes from £251,992 to £267,100 in the various capital accounts, and some simplification had been made compared with the previous year.

The notes to the Accounts gave details of how the various sums were arrived at.

Mr F. BOWN said it was disturbing to see that the administration fee had increased something like 25 per cent, which was more than normal inflation and asked whether there was a good reason for this.

The CHAIRMAN said he knew of no good reason for this.

Mr D. M. JONES (Finnie Ross Allfields) said that part of the reason was the passing on of increases in salaries paid to people working for the Institute of Marine Engineers. Also in the previous year Flemings had not charged a management fee for the Guild's investments, and therefore in the year under review there was a figure of £606 reflected. If Flemings had charged fees, the costs to December, 1978 would have been £4,800 and the administration costs to December, 1979 would have been about £5,700.

The CHAIRMAN said he had been under the impression the figure was the charge by the Institute to the Guild for services rendered by the Institute's staff. It had been practice over the past few years to give the Guild a similar amount to offset that.

Mr F. BOWN asked what percentage of the income from the investments this £606 represented.

The TREASURER said he could not answer off the cuff, but some years previously there had been discussion on the amount and, having seen a scale of fees normally charged by Flemings, his recollection was that the fees charged both to the Institute and the Guild were much below their normal fees. This could be checked. Flemings had a rising scale of fees depending on the size of the portfolio.

He drew attention to the fact that the Guild had had from the Institute in two years £10,500. When he had been preparing the accounts he had not known how much the Institute costs would be this year, and had had to estimate them, but he would try and clarify the position.

The CHAIRMAN said the question was really one more for the Institute Annual General Meeting. The Guild had hitherto—and he hoped this would continue—got the necessary grants from the Institute to cover the services supplied.

Mr F. BOWN said that in every case the income for the year was down substantially from the previous year, except in the case of dividends, and it was surprising that the administration was up by 25 per cent.

Mr J. H. GILBERTSON said that, like the Chairman, he had always thought there was a donation given by the Institute to offset the charge, but in looking at the donation from the Institute he noted that whilst it was down something like 10 per cent from the previous year it also included what he assumed to be a carry forward of £1,028 from the previous year. He said that this seemed to indicate that the donation was considerably less for the current year unless there had been a carry forward the previous year.

The TREASURER replied that this was the result of having two different financial year endings.

Mr J. JEWELL said he found the accounts became more depressing each year and he felt the Guild had not got the support that it deserved from members of the Institute. He wondered if it would be possible for the Institute as a whole to make a declaration to all its members that a certain small percentage of their subscriptions would automatically be diverted to support the Guild. If members would not join voluntarily, would it not be possible to make them pay something towards helping the Guild pay its own way.

The CHAÍRMAN replied that he was sure the whole of the Committee would be in full agreement. However, when the suggestion of having such an item on the subscription form, which could be deleted if members did not wish to support the Guild, was put to Council it was turned down by them. It would be possible to try again, but he thought the support the Guild received from the Institute was niggardly, particularly as the building in which they were sitting was built as a memorial to the engineers who had lost their lives in the last war.

Mr J. JEWELL suggested that perhaps they needed to lobby the Committee a little more strongly, and persuade them to change their minds

The CHAIRMAN replied that they would try again.

Mr J. H. GILBERTSON proposed the adoption of the Annual Report and the Financial Statement.

Mr STOKOE seconded the adoption of the Annual Report and Financial Statement, and congratulated the Committee for doing so much work over the years, and for trying to keep the Guild going.

The Annual Report and Financial Statement were adopted.

Other Business

Mr STOKOE said a note had been sent round stating that the finances of the Guild were going to be under a new heading, I.Mar.E Holdings rather than Imeg. He asked why this had been done and did the people who were paying in to the Guild realise that they were still paying in to the Guild and not in to the Institute.

The CHAIRMAN replied that the finances of the Guild were not being separated away and any subscriptions to the Guild would still get directly to the Guild. The subsidiary company had been set up to deal with the sale of ties, Christmas cards etc., to get money for the Guild, and to avoid endangering their charitable status. He understood this

was no longer necessary

The SECRETARY said that the change was designed to save money since two sets of accounts etc., had been required, and it was deemed more economic to deal with the whole thing through the Institute and pass over annually a sum of money for what had been sold. It was a streamlining process and the Guild would not lose any money, but should gain a little.

Mr STOKOE asked whether donations directly to the Guild would

still go to the Guild itself.

The SECRETARY replied that the Guild of Benevolence was a quite separate operation from the operations of the sale of goods.

Mr STOKOE thought there might be some confusion because he had received a letter saying that all cheques should be made out to the holding company, without specifying whether these were for sale of goods or not.

The SECRETARY said he had not seen the circular.

Mr F. BOWN, while a copy of the circular was being found, asked whether this meant that a different organisation would be organising the charity ball.

The SECRETARY replied that it would be the same one, insofar as Mr Williams and his two assistants in MMH had organised the charity ball since the advent of MMH in its present form.

The CHAIRMAN said the Guild had never had any control over the charity ball, which had been run by the Institute who had passed over

the net profit therefrom to the Guild as a donation.

The TREASURER said that until Imeg was dissolved the accounts had had to take care of the Institute's year end which was 30th September, the Guild of Benevolence year end which was 31st December and the Imeg Benevolent year end which was 31st March, so the figure shown in the accounts for Imeg had always been a difficult one to ascertain in time for the Accounts and was to some extent a bit of guesswork from year to year. With the dissolution of Imeg, they would then have a similar sort of figure appearing, but coming from Marine Management Holdings. The other thing which was under consideration to speed up the presentation of the accounts was to make the Guild year end coincide with the Institute year end.

Mr J. H. GILBERTSON said he would have thought that would be a good thing to do, because it would eliminate the problems of trying to get a correct transfer of funds from one to the other. He would not have thought there was any reason why it could not be implemented. Secondly, whatever they were talking of doing in terms of Imeg it was only a small amount of their income which would not present a problem wherever it was handled, as long as the accounting side was done correctly, and he was sure there was no question about that. He asked whether there was any form of procedure to go through to change the year end.

The CHAIRMAN replied that he did not think there was any procedure other than that it would have to be done at an Annual General Meeting. There was paperwork to be done with regard to

subscriptions and so on with a change of year end.

Mr D. M. JONES (Finnie Ross Allfields) said he thought the difficulty would be one which the Institute had had some years ago when it changed its year end, which was one of fixing the annual subscription. The subscriptions for 1980 were presumably already being requested. If therefore it was desired to change the accounting year as of now to a nine months period to September, 1980 it would be necessary to get the permission of the subscribers to accepting that

their subscription covered a nine months period and not a year. Looking at the rules, he could not see anything specific about change

The TREASURER said that the procedure when the Institute had changed their year end had not been quite the same. The Institute had laid down subscriptions which had obviated the need for juggling from nine months to 12 months, whereas the Guild subscriptions were very largely donations, and he did not think it mattered too much. In his experience it would be better to agree to a change in 1981, in order to allow time for the paperwork, although he realised they were not dealing with many people or a great deal of money.

The CHAIRMAN did not think the members of the Guild, who after all were giving to charity, would object if they were sent polite little notes asking them to agree that for this year their same subscription would cover nine months. If that was the only problem he could see no reason why they should not agree in a general meeting now to go forward on that basis, i.e. to give the Committee authority to go forward. If they found any snags that were insuperable they would not do it for a year.

Mr J. H. GILBERTSON said he would be happy to propose the change

Mr STOWFORD seconded the proposal.

The SECRETARY said that in principle it would be quite wrong to take the motion today because the statutory period of notice had not been given and it ranked as special business. Perhaps the meeting could agree that the matter be put on the agenda for the next Annual General Meeting.

The CHAIRMAN said they would have a concrete proposal for the next Annual General Meeting that they move the year end date.

The SECRETARY, having been furnished with a copy of the circular referred to by Mr Stokoe, said that it was a letter to all the Branch Guild representatives who held stocks of ties etc., asking them to make cheques in respect of stock to MMH Limited because of the liquidation of Imeg Benevolent, and he hoped this cleared up the confusion.

The CHAIRMAN stressed that this was only in respect of the sale of goods and did not apply to subscriptions to the Guild of Benevolence.
