INTRODUCTION

matters were referred to in particular and during 1971 it is the same five matters which have dominated the year's work. These are:

- a) the continuing evolution of the Council of Engineering Institutions: this year one of the most important elements has been the consequences of the Industrial Relations Act:
- b) the Engineers Registration Board which has now been established;
- c) continuing valuable activity by the Divisions and Branches providing services to the members throughout the world:
- the inevitable search for counter-measures to inflation which not only bites deeply but without warning whereas it takes upwards of twelve months to provide compensatory income;
- e) efforts by the staff and others not only to reduce expenditure but to increase income from sources other than subscriptions.

Divisions

Australia / New Zealand

Mr. Kerr Paxton, Secretary of the Division, died after a long illness in July. He had contributed considerably to the success and effectiveness of the Division in the vulnerable period of its first year of operation. Mr. J.B. Thomson was appointed Secretary in October in his place. Council's thanks are extended to Mr. Thomson for standing in while Mr. Paxton was ill.

The Vice-President for Australia, Captain R.G. Parker, O.B.E., retired at the end of October; Mr. E.E. Freeth has been appointed in his place.

A Divisional conference was held in November, a fuller report of which appears in the Division Annual Report.

In February the Government of India announced that it was in general agreement with the suggestions made by the Institute Indian Division in the memorandum on the training of marine engineers and indicated that efforts were being made to implement the proposals.

Canada

The Vice-President for Canada, Mr. G.W. Stead, retired In the introduction to the Annual Report for 1970 five during the year. Institute session cards would also be discontinued. An overall review of branch administration has been carried out during the year bearing in mind particularly the increased costs of running branch meetings.

to the By-Laws were approved by members at an Extraordinary General Meeting on the 22 June and these amend-Council dated 8 December.

Following this action, the By-Laws Committee began work in November on a more extensive revision of the existing By-Laws, in which the membership structure of the Institute and the form of its government would be reconstituted to conform to the general pattern set by the Council of Engineering Institutions and the Engineers Registration Board. In this more extensive revision, opportunity is also being taken to modernize the provisions of the By-Laws where appropriate.

By the end of the year, the By-Laws Committee prepared a first draft of the revised By-Laws, and other enabling documentation. It is intended to present these matters to the members at the Annual General Meeting 1972.

MONOPOLIES COMMISSION

In April, the Council, upon an invitation from the Department of Trade and Industry, made certain comments on the report of the Monopolies Commission, in which the opinion was expressed that the constitution and operation of the Institute was in general conformity with the requirements of the report.

EDUCATION AND TRAINING

The only major matter for discussion by the Education and Training Committee during the year has been related to certain proposals for raising the standards of education and training required for the Chartered Engineer, which were raised by a working party of the Council of Engineering Institutions. Arising from these discussions, the Council has made formal comments on the proposals but by the end of the year no formal decision had been taken by the C.E.I. Board.

MEMBERSHIP

Changes in the membership totals are shown in the accompanying table and chart. The present membership is 20 429. The number of new elections, 1585, is slightly lower than the figure for last year but the number who died, resigned and whose subscriptions lapsed is considerably lower than last year, the result of which is that the net increase in membership this year at 950 is 30 greater than last year. Perhaps the most significant factor in the membership figures is that the number of those resigning dropped from 289 to 181. This is still far

same time the existing conditions of inflation demanded early too high a figure as also is the figure of 345 for those who action on financial aspects. To this end, certain amendments failed to pay their subscriptions. This, incidentally, is almost exactly the same figure as for 1970 and is made up to an extent of almost 60 per cent from the Student and Proments were later approved by the Privy Council by order of bationer Student categories. This continues a trend of many years standing and so far has defied solution by the Council. In 1970 a word of caution was expressed on the subject of the consequences of subscriptions being raised at the beginning of the year and it was pointed out that the full effect of this would not be seen until 1971, in which connexion it is gratifying to know that anxiety on this score was not warranted.

LEARNED SOCIETY FUNCTION

Technical Meetings in London

During the year ten papers, in addition to the Presidential Address, have been presented at ordinary meetings at the Institute, covering a wide range of subjects of interest to marine engineers. In June, a two-day conference was held "Factors in the Selection of Marine Machinery and Plant with Particular Reference to Reliability, Maintenance and Cost". There have been six student meetings during the year and the Lloyd's Register of Shipping Award Lecture was held in March.

Specialist Sections

Three one-day symposia have been held by the Vibration, Business Management and Ocean Engineering Sections, the latter one being held in conjunction with the Society for Underwater Technology. The Marine Electrical Engineering Section has held an evening informal discussion.

Meetings in Branches

A full programme of interesting meetings was arranged by the Branches. It is regretted that few of these valuable contributions are available for publication although Council accepts that the preparation of manuscripts is a time-absorbing



PUBLICATIONS POLICY

Before the new publications policy came into force in January it was agreed that this should be reviewed after it had been functioning for some six months. Favourable and adverse comments were received both from individuals and Branches and in June a report of the new arrangements was discussed by Council. The change in policy was accepted but several amendments were agreed to improve the system; these include:

- i) the institution of a registration fee of £1 per annum for each year's issues of Transactions from 1 January, 1972. The existing ad hoc free-on-demand service remains:
- a combined notification of subscription renewal and Transactions registration fee;
- that 500-word abstracts of papers to be published as parts of Transactions should be included in Marine Engineers Review and that there should be an increase in the number of pages published in each issue of M.E.R.

EUROPORT 71

The Institute took a stand for the first time at the Exhibition, although the 1970 exhibition had been attended by observers, which was held in the RAI Halls in Amsterdam Engineers Review was published to coincide with the exhibition and the effect of this, the production and distribution of literature about the Institute and the presence of some reflect both inflationary trends and increases in the services members of Council together with those staff manning the themselves, both in terms of quality and level. DEPARTMENT OF TRADE AND INDUSTRY CERTI-**FICATES**

The Department of Trade and Industry First and Second Class Certificates are being considered by a Qualifications Panel of the Engineers Registration Board as being acceptable entry qualifications for the technician sections of the Board.

THE JOINT POLICY COMMITTEE (consisting of the Institute, the Institutions of Mechanical and Production Engineers together with the Royal Aeronautical Society and the Royal Institution of Naval Architects).

Mr. B. Hildrew, M.Sc., past Chairman of Council, has chaired the Committee throughout the year. Of the subjects discussed for collaboration, environmental engineering and ocean engineering have drawn most attention.

FINANCE AND ACCOUNTS

The Accounts have been re-drafted in a modern format which it is hoped will be more easily found informative by members. At one time they reflect an accurate but concise picture of the total Institute operation.

1) Revenue

Subscription rates have not been increased during the year and the higher level of subscription income is therefore attributable to the continued high level of membership growth.

Income from investments has been exceptionally large, in part due to the continued returns from the exercise of greater control of the Institute's internal cash resources mentioned in last year's Report and in part to exceptional dividends from Gilt Edged holdings.

Income from publications includes both advertisements (up 30 per cent) and sales of publications (up 55 per cent). The very substantial increases in these sources of revenue are the result of the new publications policy and a greater internal accent on the importance of these functions to the Institute's finances. Publications, both on the income and on the expenditure side, are as vital financially to the Institute as they are technically. If the publications can be made financially viable within a framework of providing an ever-increasing technical service to members then the rate of increases in membership subscription rates could continue to be kept below the general rate of inflation thereby increasing the value of the Institute's services in real terms.

Rental income continues to be static save in one small from 9 to 13 November. A special supplement to Marine area where charges made are continually reviewed to obtain the maximum possible benefit.

The expenditure on services to members continues to

trends are in the result less than would otherwise have been the case because of rigorous action taken to control overhead costs stemming from the introduction of long term budgeting reported last year. The unfortunate and unexpected death of Mr. Pearce has meant a considerable internal reorganization which in turn has meant that certain planned developments have not been undertaken. This could mean that the lack of expenditure under this head might result in a loss of momentum in future development; considerable efforts are to be made in 1971/1972 to redeem the position.

The protracted postal strike has affected the Institute to a considerable extent and financially has meant a loss of advertisement revenue of an incalculable amount and a loss of interest as members were unable to pay their subscriptions promptly. This loss of interest amounts to approximately £800.

To summarize, the revenue position is satisfactory and the surplus larger than that budgeted due to the lack of development expenditure on the one hand, partly counter-balanced by the loss due to the postal strike.

The outlook is a matter for some concern unless the rate of inflation drops and its effects can be contained.

2) Balance Sheet

The increase in the total assets reflects the revenue surplus. The increase is not, however, sufficient to cover the effects of inflation upon the real value of the Institute's reserves. The need to budget for sufficient surpluses to attain this aim, whilst at the same time not in any way restricting the Institute's development, must be reflected in future financial decisions and be taken into account in long term budgeting.

COUNCIL OF ENGINEERING INSTITUTIONS

Manpower Survey

The 1971 Engineering Manpower Survey has been undertaken by C E I alone, not, as in the 1966 and 1968 surveys, as a joint operation with the then Ministry of Technology. Mr. B. Hildrew, M.Sc., (past Chairman of Council) chaired the evaluating Committee. The report of the results of the survey is now on sale.

MacRobert Award

The 1971 MacRobert Award of a Gold Medal and a prize of £25 000 has been awarded to the Gas Council Research team which has evolved several elegant processes in the manufacturing of gas. The team is:-

Industrial Relations

The Industrial Relations Bill has completed its passage through Parliament and some changes in its text reflect the influence of C E I and other professional organizations.

The CEI Working Party on Industrial Relations has considered actively how the needs of Chartered Engineers can best be catered for and has briefed and supported the C E I officers in their discussions with Ministers, officials of the Department of Employment and many others, including members of both houses of Parliament, concerned with this important piece of legislation.

A definite Institute policy has not been able to be formed

Council has agreed, however, to co-operate with CEI and all its member institutions in producing a uniform Code of Ethics for all institutions to be the basis of a Code of Professional Conduct for adoption and incorporation by all institutions as a pre-requisite to their being able to apply for registration on the Special Register. Legal advice is being taken on any possible effects of registering on the Special Register on the status of the Institute.

Value Added Tax

A working party has been set up to discuss proposals to introduce Value Added Tax and how this could affect subscriptions, examination fees and other educational activities of professional institutions.

Commonwealth Engineering Conference

C E I was host to the meeting of CEC in London in June. The Chairman and the Director and Secretary represented the Institute at various sessions.

World Federation of Engineering Organizations

The Chairman and the Director and Secretary represented the Institute at the Third General Assembly of WFEO held in Varna, Bulgaria in July.

FEANI International Engineering Congress

The fifth FEANI Congress was held in London in September and marked the 20th Anniversary of the founding of FEANI. The Congress coincided with the end of Sir Frederick Warner's three year term of office as President of FEANI.
