SUMMARY

Introduction

- The Maritime Safety Committee (MSC), at its eighty-fourth session, approved the Sub-Committee on Standards of Training and Watchkeeping (STW) recommendation to convene an *ad hoc* intersessional working group in September 2008 to continue to make progress on the comprehensive review.
- The Sub-Committee on Standards of Training and Watchkeeping, at its thirty-ninth session (3 to 7 March 2008), established a working group on the comprehensive review of chapters I, II, III, VI and VIII. The working group considered the proposals contained in STW 39/7/3 (Australia *et al.*) and agreed that competence requirements relating to communication should be placed under Table A-VI/1-4 under the existing competence "contribute to effective human relationships on board ship." The working group invited Governments to submit new proposals.
